2. PURPOSE

This Agreement establishes the terms for reserving a caseta space at La Feria de Sevilla en Miami 2027, to be held at Tropical Park on March 5 (half day) and 6 (full day), 2027, subject to approval by the Organizer and compliance with all event regulations.

3. APPLICATION & RESERVATION FEE

To be considered for a caseta, the Applicant must:

Submit a completed application form

Execute this Agreement

Pay the \$500 reservation fee per caseta

All of the above must be received by December 1, 2026.

The reservation fee will be applied toward the total caseta price.

Submission of the application and payment does not guarantee approval.

No reservation, right, or entitlement to a caseta exists unless and until the Applicant receives written approval from the Organizer.

If the application is not approved, the reservation fee will be refunded in full.

4. APPROVAL & ASSIGNMENT

All casetas are subject to review and approval by the Organizer. The Caseta Application Form must be fully completed and submitted for review prior to the execution of this Agreement or the submission of any payment. Submission of an application does not guarantee approval or reservation of a caseta space.

The Organizer reserves the right to approve, reject, or revoke any application at its sole discretion.

Final caseta placement and layout will be determined and assigned by the Organizer at its sole discretion during the week prior to the event and may be modified at any time based on operational needs.

5. PAYMENT TERMS

50% of the total caseta fee is due by December 1, 2026.

The remaining 50% is due by February 1, 2027.

Time is of the essence.

Failure to meet payment deadlines will result in:

Immediate cancellation of the application or reservation

Forfeiture of all amounts paid

Release of the caseta for reassignment by the Organizer

6. CANCELLATION & REFUND POLICY

The \$500 reservation fee is non-refundable under all circumstances, except if the application is not approved.

If the Applicant cancels for any reason before January 15, 2026:

The reservation fee remains non-refundable

Any additional amounts paid may, at the Organizer's sole discretion, be partially refunded (50% of the amount paid)

After January 16th, 2026, no cancellations, reductions, credits, transfers, or refunds of any kind will be granted, regardless of the reason, including, but not limited to, personal circumstances, business decisions, weather concerns, or changes in participation.

Failure to attend or utilize the caseta does not entitle the Applicant to any refund or credit.

7. FOOD & BEVERAGE POLICY

Casetas may not operate independent bars.

All beverage services must be contracted through the official event provider.

Food must be pre-ordered through designated vendors.

No outside food or beverages allowed without prior written approval.

8. COMPLIANCE

The Applicant agrees to comply with all applicable:

Local regulations and permits

Health and safety requirements

Event operational guidelines

Failure to comply may result in immediate cancellation without refund.

9. LIABILITY

The Organizer is not responsible for loss, theft, or damage to Applicant's property.

The Applicant assumes full responsibility for their caseta operations, staff, and guests.

10. FORCE MAJEURE

In the event the festival is canceled, postponed, or materially modified due to circumstances beyond the Organizer's control (including but not limited to weather conditions, government restrictions, public safety concerns, or acts of God):

The Organizer may, at its sole discretion:

Reschedule the event, or

Apply all payments as a credit toward a future edition

No refunds shall be issued under any force majeure circumstances.
